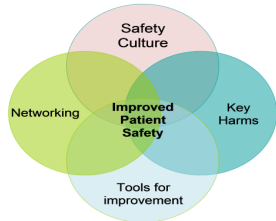

There is a new **National Maternity Collaborative** that the Improvement Academy will be supporting along with other strategic partners in the region; a renewed focus on the **Deteriorating Patient** and finally **culture of safety** building on the work we have been doing across the region.

Bespoke Quality Improvement Training

The Improvement Academy has been commissioned by Health Education Yorkshire & Humber to deliver quality improvement training to ST4+ doctors. We are running 4 sets of a 2-day training package, 2 each in Leeds and Sheffield. The days have been set one-month apart with the intention that in the first session trainees develop a plan for an improvement project, which they then work on during the interim month. 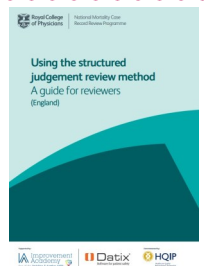

Structured Judgement Review Methodology recommended by Department of Health

On 21st of March 2017, the Department of Health announced a **National Mortality Framework** to learn from the care of patients who have died. The Improvement Academy is delighted the Structured Judgement Review (SJR) was recommended as one of the methodologies for a standardised approach to mortality reviews in NHS trusts.

The **Yorkshire & Humber mortality programme** was set up in 2014 and is entirely shaped by frontline clinicians. 12 acute and mental health trusts in the region are now successfully using the SJR as part of their clinical governance structure to learn about both the good and not so good care in their health processes. The thematic analysis of the reviews is used as the basis for quality improvement initiatives. The Improvement Academy is also working in partnership with the Royal College of Physicians to roll out the SJR methodology across England & Scotland.
